- ✓ Demonstrated expertise in the area of EU circular economy and waste management policy via previous employment experience and/or consultancy assignments;
- ✓ Demonstrated experience in (leading) the delivery of consultancy assignments;
- ✓ Demonstrated experience in carrying out (pro-active) business development and acquisition in the required areas of expertise, together with a good network of established contacts with practitioners and clients within the (European) circular economy policy community;
- ✓ Ability to work, write and communicate fluently in English. Ability to work in any additional languages (such as Dutch, French, Spanish, or German) is considered as an advantage;
- ✓ Eligible to work in the European Union.
