  - **Quantitative, qualitative, and mixed methods research and analysis;**
  - **Advisory.**
- In-depth knowledge of **EU environment policies and policy instruments** in at least one of the following areas, as well as the wider policy context, is expected and should be demonstrated via previous employment experience and/or consultancy assignments:
  - **Clean water, flooding, oceans, blue economy in a EU perspective;**
  - **Air pollution and industrial emissions.**
- Interest to work on a wide range of EU environmental policy issues within these domains;
- Ability to work, write and communicate fluently in English;
- Very good writing and analytical skills;
- Eligible to work in the European Union (EU).
