- ✓ In-depth knowledge of the relevant strategies, policies, instruments and tools in the area of **EU and international sustainable finance (e.g., green finance tracking, EU Taxonomy, ESG disclosures, greening of financial systems, climate risk analysis, SDG- and TFCD-aligned reporting)** is expected and should be demonstrated via previous employment experience and/or consultancy assignments.
- ✓ Demonstrated experience in managing and coordinating project teams;
- ✓ Demonstrated experience in carrying out pro-active business development and acquisition in the required areas of expertise, together with a good network of established contacts within the sustainable finance community;
- ✓ Ability to work, write and communicate fluently in English. Ability to work in any additional languages (such as Dutch, German or French) is considered as an advantage;
- ✓ Eligible to work in the European Union (EU).
